Additional Billed Services:

The purpose of the Academic Accommodation Plan (AAP) at HOPE Christian Academy (HCA) is to provide Christ-centered academic support for students who have shown signs of learning difficulties. Services are offered to students through a variety of techniques including traditional resources and classroom support for students and teachers. AAP services focus on helping students reach their academic potential in a regular educational setting. Services are designed for students with mild academic difficulties. The program is not intended to replace specialized assistance for students with more severe learning/behavioral problems or other types of disabilities. The HCA Administration determines if a student's individual needs can or cannot be met and may recommend alternative school placement. Accommodations at HOPE are offered on three levels with the following charges made to cover the added administrative, teacher, and interventionist involvement.

Tuition is billed in 10 installments August - May. The first month's tuition statement will be emailed in the last week of July to each family and payment will be due to the school office on the first day of school. Subsequent balance due statements will be sent home via email in the week prior to the beginning of each billed month. Tuition is due and payable on the first day of each of the ten billed months; a grace period of 5 days is given before a late fee of \$50 per family is applied (late fees cannot be paid with scholarship funds).

Families with ESA students (available to Kindergarten - 8th grade only) will receive quarterly statements equal to 2.5 months to submit to ClassWallet for payment by the ESA. Quarterly statements are delivered to families to closely correspond to the funding schedule of the ESA. It is expected that provided tuition statements be submitted to ClassWallet within two weeks of delivery.

Preschool and Pre-K tuition is not eligible for tax credit scholarships or the ESA. The state of Arizona caps Kindergarten ESA funds at approximately 60% of the amount available to students in 1st through 12th grades. Parents of Kindergarteners using the ESA will be responsible for payment of the shortage once the quarterly ESA payment has been processed.

Payments, Fee Caps, Discounts, and Withdrawals

Payments

HCA offers several payment methods for tuition. Cash or check payments can be made directly to the school office by hand delivery or mail (not recommended for cash payments). Personal banking direct payments can be sent to the school address, and Zelle payments can be made to hca@hope-eagles.com.

Fee Caps

Registration and re-enrollment fee maximums are *limited to fee type*. If a family is looking to re-enroll and first-time enroll students in the same academic year, total fees have the potential to exceed the stated fee type maximums. For example, if a family is re-enrolling four students and also enrolling a new student (in any grade), the maximum re-enrollment would be capped at \$600, but the new student would pay \$300.

Discounts

Being aware that STO and ESA dollars are not available for preschool students, and recognizing that ESA dollars are not currently high enough to fully cover our Kindergarten tuition, we are pleased to offer a multiple child discount for any HOPE family who has students enrolled in both Preschool and Kindergarten. Families who have students both in HOPE Preschool and Kindergarten will receive a 10% discount on their preschool tuition.

Withdrawal

If a student is withdrawn between August 1st and August 15th, payment of the first full month's tuition will be expected.

Mid-year withdrawals require a written two-week notice. Tuition will be prorated for any partial month, to account for any unattended school days past the notice period.

If tuition has been paid for the current month, a refund for any remaining school days not attended beyond the two week notice will be processed. For families utilizing the ESA or scholarship for tuition payment, any refund due will be processed to the appropriate ESA or scholarship account.
